



# 2020 HOLD HARMLESS AGREEMENT

THIS AGREEMENT IS ENTERED into by and between the Aberdeen Sunday Market (WHOLE Harbor) hereinafter called "Aberdeen Sunday Market") and

In consideration for being allowed to enter and/or participate in the 2020 MARKET SEASON by ABERDEEN SUNDAY MARKET / WHOLE Harbor, and the services that are provided to VENDOR in connection with its ABERDEEN SUNDAY MARKET 2020 MARKET SEASON – SUNDAY, June 14 through SUNDAY, September 13, 2020, with possibly other later dates, as an adjunct to and part of any vendor agreement relating to VENDOR’s presence or participation in the ABERDEEN SUNDAY MARKET 2020 MARKET SEASON, VENDOR releases ABERDEEN SUNDAY MARKET and WHOLE Harbor, its agents, employees, volunteers, and assignees (the “protected parties”) , and agree to hold them harmless from any and all potential or actual liability relating to VENDOR’s participation or presence at the ABERDEEN SUNDAY MARKET 2020 MARKET SEASON, including from their own negligence or fault, and assume all liability from any cause whatsoever relating to, arising out of, or otherwise connected with the participation in or presence at the ABERDEEN SUNDAY MARKET 2020 MARKET SEASON, of VENDOR or any of VENDOR’s employees/employer, agents, helpers and guests, including but not limited to all liability from any cause whatsoever for personal injury or property damage, as well as for contribution or indemnification. The protection of this agreement extends, but is not limited to any and all contractual liability ABERDEEN SUNDAY MARKET may have for tort damages to premises.

This agreement shall be given a liberal construction to accomplish its protective purposes such that all ambiguities are resolved in favor of the Protected Parties. If any provision of this agreement is deemed to be partially void, invalid, or unenforceable, that provision shall continue in full force and effect to the maximum extent permitted by law and all remaining provisions of this document shall continue in full force and effect. To the extent that any provision of the agreement is deemed to be completely void, invalid or unenforceable, that provision shall be severed from the remainder of this agreement and all otherwise valid or enforceable provisions of this agreement shall continue in full force and effect. VENDOR has read and fully understands the contents of this document. VENDOR agrees to the terms and conditions stated above.
